

The YLD Microgrant* Program is part of YLD's ongoing efforts to create a thriving, vibrant Jewish Cleveland young adult community by empowering individuals or groups to create, plan, and host experiences for Jewish Clevelanders (ages 22-45). Applicants are able to apply for up to \$1000 to support their projects per calendar year.

*A YLD Microgrant is pre-approved funding for a program or project in the Cleveland Jewish Community geared towards young adults, ages 22-45. Young professional groups or individuals will be reimbursed for expenses (up to the agreed upon amount) after completion of their project.

APPLICATION PROCESS:

- 1. Applicants must complete an online application outlining their project and budget.
- 2. Funding will be available each year: application deadline is December 31, 2019.
- 3. Applicants will be notified as to whether and to what extent they received any funds for their project within 30 days after the application deadline.
- 4. December 31 Microgrant Recipients must utilize their funding by June 30, 2020 unless otherwise agreed upon in the application acceptance/award letter.

In a situation where one applicant (or young professional group) collaborates with another, the \$1,000 per person (or young professional group) per year limit still applies.
- *iv.* Successful applicants will be reimbursed after their program/initiative. Receipts/proof of payment must be submitted with the completed budget chart.
